# 3. REVIEW OF ACTION ITEMS AND APPROVAL OF MINUTES

- **Vanguard Withdrawal** The Board decided to not make the annual withdrawal (5% of our 12-month's trailing average balance) from our Vanguard Wellington Fund in 2019.

- **Sound System Purchase** Pending. Doug needed the right forms which were provided by Tim and Hannah. If he can't get it tax free, Doug will pay the tax himself.
- New Percussion Stands-Pending.
- BMI Report-Richard compiled lists provided by Dominic, Doug, and Tim and sent the report.
- 2020 Concert Season-Nothing concrete yet. Don, Janis, and Tim talked with Crystal Ritter of Parks and Rec about the possibility of setting up a summer concert series along with other community music groups during the summer months. Both Crystal and her boss seemed interested. She is not quite ready to talk about it since the lawn in front of the amphitheater is not ready. Playing inside of the Pavilion might be an option. The goal is to cut the number of concerts down to around ten concerts per season. We would like to get a public Christmas

concert scheduled as well. We are no longer performing at nursing homes with the full ensemble. We will approach College Mall again for Christmas performances. Boys and Girls Club hosts an annual coat drive. This may be a good fit for a charity to tie to the event.
